# 2023 GREAT LAKES FISHING DECREE

On August 24th U.S. District Court Judge Paul L. Maloney issued an Opinion and Order approving and entering the 2023 Great Lakes fishing decree. GTB together with BMIC, LRB and LTBB as well as the U.S. and State (6 of the 7 parties to the "United States v. Michigan" litigation) had filed the proposed decree with the Court on December 11th after Judge Maloney ruled in GTB's favor on December 2nd in the dispute with the State concerning provisions of the Grand Traverse tribal zone section of the proposed decree. 

Almost 5 years after the process began in September, 2018, the Court has approved what in effect is an extension of the zonal plan framework first adopted in the 1985 decree and then modified in 2000. This is the position GTB advocated 5 years ago, but the Upper Peninsula tribes (Bay Mills and Sault Tribe) staked out a different position that caused a great deal of strife among the 5 tribes.




# **TRIBAL COUNCIL MOTIONS**

During the early discussions among the Tribes in 2018-19, the U.P. tribes insisted that our exclusive tribal zone be eliminated. Our Natural Resources & Environmental Committee said "no" and recommended that Council formally take a position in support of retaining our exclusive zone, which Council did; and Council also approved a litigation budget enabling our lawyers and expert witness to present evidence that the Court relied upon in the August 24th decision. Eventually Bay Mills agreed to the continuation of the zonal plan, with only the Sault Tribe opposed; and the Court's August 24th decision resolved those objections.

The series of maps printed with this announcement demonstrate the progress we've made in the past four decades to re-establish our treatyreserved fishing rights within our traditional home waters. Due to intense fishing effort by Bay Mills and Sault Tribe fishers after Judge Fox's May 7, 1979 decision, state court and federal



appellate court orders prohibited all Indian fishing within Grand Traverse Bay — thus GTB was prohibited from fishing in our home waters adjacent to our reservations reserved in the 1836 and 1855 Treaties. Over time (1985 and 2000 decrees, and now with the



It's far from perfect; after all, the U.S. Constitution says our treaty rights are the "supreme Law of the Land." But we also are located within the most important tourism/recreational fishing area of the state, and we share the fishery resource with the state's citizens.

All in all, we think that the new decree is a reasonable compromise regarding commercial fishing opportunities within our tribal zone: more than half of the lake trout harvests are allocated to GTB; we have an opportunity to target salmon starting August 1st instead of waiting until after Labor Day; and expanded gill net waters that allow GTB fishers to explore for additional fishing opportunities for whitefish and other species. Please understand that these maps pertain only to commercial fishing. There are no limitations where GTB citizens may fish for subsistence purposes with gill nets under tribal law or for "recreational" purposes without purchasing state licenses.

# PUBLIC LAW 100-472 AND THE SELF-GOVERNANCE DEMONSTRATION PROJECT

On September 15, 1988 (a little over six months after GTB's Tribal Constitution was approved by the BIA) Congress signed amendments to the Indian Self-Determination and Education Assistance Act of 1975/Public Law 93-638 ISDEAA). These amendments to the Act allowed for the Self-Governance Demonstration Project. In 1987 a challenge to this Project was proposed, with no consultation with tribes, which would have provided a waiver of the federal trust relationship for participating tribes – luckily this proposal was defeated, although it created fears that tribes would be terminated. According to a 1999 report by the Senate Committee on Indian Affairs:

[F]ears of termination via the self-determination/selfgovernance process...were heightened when DOI, through then-Commissioner of Indian

nationwide. (Amending the Self-Determination and Education Assistance Act to Provide For Further Self-Governance by Indian Tribes, and For Other Purposes, Senate Committee on Indian Affairs Report, Nov. 9, 1999, page 72)

In response to the DOI's Section 209 proposal tribes across the nation provided their own proposal, and after related negotiations resulted in the tribes' Self-Governance Demonstration Project.

On October 1, 1992 (four years after the passage of P.L. 100-472) GTB became the 17th Self-Governance Tribe in both the BIA and IHS federal agencies. GTB has been a selfgovernance Tribe since then, and negotiates with the federal government on an annual basis for contract support funding.

# National and State American Indian

**Day.** On Niizhtana-shi-niizhgwongizi (the 22nd) of this month is National and State American Indian Day. The fourth Friday in September was designated as Michigan Indian Day in 1974 by the state of Michigan Legislature's Public Act 30. It is not a state holiday, but it is a designated holiday at GTB to celebrate our heritage as Native peoples.


# FALL BEGINS

Dagwaagin, or early fall, officially begins on Niizhtana-shi-nsogwon-gizi (the 23rd) of this month. Traditionally, this is the time for harvesting manoomin (wild rice), gathering of wild berries, such as chokecherries and early cranberries, hunting and fishing; preparation of foods for storage was vital for the long winter months ahead. 



# NAHASDA Rental Subsidy Assistance

\*Please note the differences in the programs\*

Eligibility for Rental Subsidy Assistance

A. To be eligible for rental assistance, applicants must meet all of the below conditions:

- 1. Be an enrolled Tribal member of the Grand Traverse Band;
- 2. Be eighteen (18) years of age or older;
- 3. Reside in one (1) of the following counties: Leelanau, Grand Traverse, Antrim, Charlevoix, Benzie, or Manistee;

4. Qualify as a low-income family, defined as a family whose income does not exceed 80% of the median income, as published annually by Office of Housing and Urban Development (HUD);

5. Live in a space that requires rental payment. For example; apartment, mobile home park, town house, etc. Rental assistance will not be offered for assistance with mortgage payments, lot rent (of participant owned/mortgaged home) or when renting an individual room;

6. Not be delinquent on their rent at the time assistance is offered;

B. The applicant is eligible to receive **<u>up to</u>** \$250.00 per month for rental assistance.

C. Rental assistance may be provided for a maximum of six months in a two-year period.

D. Applicants who receive benefits and become ineligible due to receiving the maximum six months of benefits are eligible to re-apply two (2) years after date of initial application.

E. An applicant may not receive rental assistance while receiving the benefit of any other form of housing subsidy for the same dwelling unit. (with the exception of the ARP supplemental assistance)

F. Applicants that owe monies to the Grand Traverse Band Housing Department are not eligible for Rental Subsidy Assistance until the balance is paid in full.



# **MICHIGAN SUPREME COURT DENIES** LEAVE TO APPEAL FISHPASS CASE

On August 22, 2023, the Michigan Supreme Court denied leave to appeal in the FishPass case, which confirms the Court of Appeals decision and allows the City of Traverse City to implement the project. At issue in this lawsuit was whether the City Charter required a public vote prior

According the to Michigan Supreme Court, "The application for leave to appeal the October 20, 2022 judgment of the Court of Appeals is considered, and it is denied, because we are not persuaded question that the presented should be reviewed by this Court."

City Attorney Lauren Trible-Laucht who

argued the City's case before the Michigan Court of Appeals, indicated, "The Michigan Supreme Court's decision to uphold the Michigan Court of Appeals ruling regarding the FishPass project is indeed a positive development. This decision affirms the City's choice to implement the project, which aims to replace the aging Union Street Dam, protecting the health and safety of downtown Traverse City, while also restoring and improving the ecological health of the waterways in the area."

The Michigan Court of Appeals decision did not address whether the property was actually parkland. Instead the Court held that assuming it was parkland a vote still would not be required under the City Charter. According to the Court's opinion in October 2022, "...the Project will result in a net gain of parkland and more public use. The Property will remain a park under the Project." Furthermore, "The trial court based its decision largely on the Project's research elements, but occupying space on the Property for purposes of conducting research related to the passage of fish, which matter has been part of the operation of the Dam and a characteristic of the Property since the addition of the fish ladder in 1987, does not transform the park into something other than a park. Moreover, engaging in environmental research concerning the habitat of species found in the area has a natural connection to the Property's purpose and use as a park. There is no evidence that the Project involves selling, exchanging, leasing, or alienating the Property. The City

retains ownership of the Property throughout the duration of the Project. Authorizations to perform work or research on the Property do not entail the sale of the Property, an exchange of the Property, the leasing of the Property, or the alienation of the Property. At most, they convey a simple license."




Figure 1. Conceptual rendering of the FishPass facility. The Boardman River flows from bottom to top. Site features include: (A) new pedestrian connection to Cass St.; (B) rehabilitated boardwalk and accessible kayak launch; (C) labyrinth weir; (D) kayak portage rail; (E) pedestrian bridge; (F) kayak shore access; (G) interpretive overlook 1; (H) outdoor classroom and amphitheater; (I) fishing area; (J) bypass channel with boulder armoring and native vegetation; (K) fish-sorting channel; (L) interpretive overlook 2; (M) ) service drive/pedestrian walk on city easement; (N) FishPass researcher building/public restrooms; (O) pervious pavers; (P) Turfstone vehicular access; (Q) research access way and security fence; (R) new boardwalk; (S) tailwater entrance pad; (T) boardwalk overlook and accessible kayak launch; (U) rain garden to manage building/parking runoff; (V) stream riffle habitat; (W) future boardwalk by others; (X) reconstructed stairs; and (Y) stairs to be removed

FishPass is the capstone of an approximately 20 year restoration project on the Boardman/Ottaway

Traverse River, City, Michigan, re-connecting with river Lake the Michigan. In 2021, а MDEQ required Dam Safety Unit inspection was performed and indicated rating downgraded а from Good to Fair/Poor condition. FishPass will replace the deteriorating Union Street Dam with a new, complete barrier to all fish that will have the ability to sort and selectively pass desirable fishes while blocking harmful invaders like sea lamprey. While fully automated selective passage is the longterm goal of the project, passage of any fish during the initial 10 years will be coordinated with fishery

# CELEBRATING HEALTHY AGING MONTH: COMMUNITY'S COMMITMENT TO ELDERLY WELL-BEING



Dr. Jessica A. Rickert, DDS, Anishinaabe Dental Outreach, is the first female American Indian Dentist, a member of the Prairie Band Pottawatomi Nation. She attended the University of Michigan School of Dentistry and practiced in private practice and at the Family Health Care FQHC located in Baldwin. She is an adjunct faculty instructor and preceptor at the University of Detroit Mercy School of Dentistry and University of Michigan School of Dentistry. She is also a past president of the Resort District Dental Society. She is the author of Exploring Careers in Dentistry, has written numerous articles, and has served as a speaker and consultant. She has been inducted in the Michigan's Women's Hall of Fame and is a recipient of the Ida Gray Award from the University of Michigan School of Dentistry.

# HOW'S YOUR SMILE?

Let's ask our elders, "How's your smile?" Not only is it the first thing people notice, but good oral health is a gateway to our overall well-being. Research shows people who smile more often bring joy to those around them, and smilers themselves are happier.

We Anishinaabe are a community that cherishes its precious citizens aged 60 and older. In September, we celebrate Healthy Aging Month by helping our elders build resilience as they age. This annual observance focuses on the positive aspects of growing older. The mission of Healthy Aging Month is to inspire and promote personal responsibility for one's health... be it physically, socially, mentally or dentally.

**Michigan Indian Day** is an excellent opportunity to better understand and appreciate the many contributions that Native American elders have made to our state; celebrated every year on the fourth Friday of September, this year we celebrate on **September 22, 2023**.

## **AGING ANISHINAABE**

Aging Anishinaabe do experience a decline in numerous aspects of their lives. Resilience, hardiness, energy, vigor, and immunity wane with each decade. The prevalence of systemic diseases that impact the mouth increases, making older adults more susceptible to oral health issues. Likewise, poor oral health can contribute to worsening physical health.

Our elders might also participate in harmful habits such as smoking and alcohol use. The effects from both are increasingly harmful to the teeth as we get older. Additionally, some older adults take a myriad of medications for various conditions. A large number of these health conditions and medications cause dry mouth, alteration to taste, and oral ulcers.

Previous dental restorations may begin to break down and require repair and/ or replacement. High levels of oral bacteria can result in rampant decay, especially along the root surfaces. These same bacteria can dislodge from the mouth and can be aspirated, causing pneumonia. Gum disease may rapidly progress with certain bacteria present. Dental disease or wearing dentures can affect nutrition because people prefer soft, easily chewed foods instead of healthier foods such as fresh fruits and vegetables.

Recent studies by the National Institute on Aging strongly suggest that older adults with poor dental health have a higher risk of cognitive impairment and of Alzheimer's disease and related dementias. The reason for this is unclear. Bacteria and the associated inflammatory molecules can travel from infections in the mouth through the bloodstream to the brain, including the plaques of beta-amyloid protein.

#### THE LINK BETWEEN AGING AND ORAL CANCER: WHY OLDER ADULTS ARE AT HIGHER RISK

Cancers of the mouth (oral and pharyngeal cancers) are primarily diagnosed in older adults; the average age at diagnosis is 62 years old. Chemotherapy is the use of drugs to treat cancer. These drugs kill cancer cells, but they may also harm normal cells, including cells in the mouth. Side effects include problems with your teeth and gums, and the glands that make saliva. Those patients with excellent oral health prior to a cancer diagnosis tend to fare much better.

With age comes many disabilities that can affect an individual's capacity to maintain good oral self-care. We ask that caregivers help older individuals brush and floss their teeth, if the elders are not able to perform these activities independently.

## IMPROVING ORAL HEALTH EDUCATION AND AWARENESS AMONG AIAN ELDERS

Older American Indians and Alaskan Natives (AIAN) report the following: The prevalence of complete tooth loss for Native American elders is higher than the general population; only **5** out of **19** AIAN elders have enough teeth to chew food well, compared to **7** out of **10** in the U.S. middle class; **49%** of AIAN over 55 years of age have untreated dental cavities. Twice as many AIAN report the following, compared to other older Americans: poor oral health mouth pain; and avoiding certain foods because of the inability to chew.

## THE AMERICAN DENTAL ASSOCIATION RECOMMENDS THAT OUR ELDERS:

•**Brush** teeth twice or more per day. Use an oscillating power toothbrush and other mechanical aids.

•**Floss** regularly. There are also other interdental cleaning aids available.

•Fluoride is a proven cavity-preventing mineral. Use daily fluoride toothpaste, a fluoride rinse and fluoride varnish treatments at the dentist's office.

•Visit your dentist routinely for a **checkup** and cleaning.

We may not be able to control the aging process, but why not control what we can? Let's achieve excellent dental health. This will enhance our ability to speak, smile, taste, chew, swallow, and convey feelings and emotions through our beautiful smiles.

#### **SMARTPHONE APP** AIMED AT REDUCING HARM

LANSING, Mich. – In an effort to reduce the occurrence of overdoses and help residents learn to treat an overdose, the Michigan Department of Health and Human Services (MDHHS) launching is <u>OpiRescue</u>, a smartphone app aimed at reducing harm.

The OpiRescue app helps including first anyone, responders, prevent opioid misuse and reduce opioid overdose deaths by addressing education, prevention and tracking of overdose reversals.

# Weathering the Storm: Financial Emergency Preparedness and Recovery

A financial emergency is any expense or loss of income you do not plan for, like a missed paycheck, a damaged roof, a flat tire, or medical bill.



Financial emergencies encompass various situations, such as car damage, unemployment, medical expenses, property damage, or unexpected family crises. It's crucial to take proactive steps to safeguard yourself in case such an emergency arises.

Begin by initiating an emergency savings account. Starting with small contributions, like \$5 or \$10 per week, is an effective initial step. Crafting a budget to estimate your monthly earnings and expenditures is essential. To alleviate debt,





consistently make payments of at least the minimum amount due, and ensure bills are paid on time to uphold a favorable credit score. Evaluate your insurance coverage, including flood, health, homeowners, or renters insurance. Keep in mind that flood insurance generally requires a 30day waiting period before taking effect; renewal on an annual basis is vital. Formulate and periodically emergency update an plan, potentially using the Emergency Financial First Aid Kit (EFFAK) as a helpful resource. Having a wellstructured plan enhances your readiness in emergency situations. Safeguard important records and retain receipts, essential both digitally and in a waterproof, fireproof container. Document your possessions through photographs and videos, which can be indispensable for repairs, replacements, or rebuilding post-disaster. Maintain a secure stash of cash to access if ATMs are unavailable. Seek guidance from certified financial counselors or coaches, either through qualified local organizations or non-profits, to adeptly manage your finances before & after crisis.



# IN THE EVENT OF A FINANCIAL EMERGENCY, UTILIZE YOUR EMERGENCY SAVINGS FOR ESSENTIALS SUCH AS FOOD, FUEL, AND TEMPORARY LODGING.

Connect with credit card companies and lenders to explore payment alternatives that prevent late fees, interest accrual, and credit deterioration. List your current expenses and negotiate for extensions with lenders. Seek assistance by DisasterAssistance. visiting gov, contacting Disaster Recovery Centers, or dialing for community-based 211

referrals. Collaborate with community organizations and faith-based groups for aid in covering day-to-day necessities and accessing additional resources.

Check your eligibility for financial disaster relief on DisasterAssistance.gov. Engage with a Disaster Recovery Center in your vicinity to access essential resources from FEMA and local organizations. Document property damage and promptly inform insurance provider. your If applicable, file a flood insurance claim and work closely with your insurance adjuster and agent for guidance. Exercise caution against post-disaster scams and never divulge personal identification numbers. Prioritize spending and

your consolidate credit card information in one comprehensive list. Analyze your spending needs and protect your credit standing. Investigate potential tax breaks that align with your circumstances. If your living situation changes, consider turning off utilities to curtail expenses.


