**PETITION TO HAVE MONIES OWED PAID THROUGH MONTHLY PAYMENT PLAN**

If the entire balance is paid in full before the Per Capita Distribution date for each case, the \$100 Administrative Fee shall be waived.

Defendant's Petition is hereby **DENIED**.
